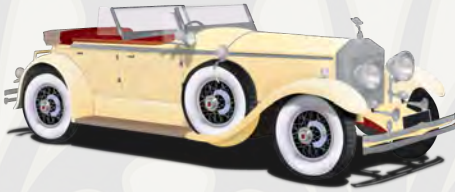

Vote "YES" for Operation Round Up

Rosalyn Carter once said, "Do what you can to show you care about other people, and you will make our world a better place." To help make a positive impact in your community, MJM would like the Membership to vote on adopting Operation Round Up at the 81st Annual Meeting.

Members have read the articles from MJM's monthly newsletter or received the educational handouts advocating for Operation Round Up. For those who have not yet heard about this movement, it is a program that was started by Palmetto Electric Cooperative in South Carolina in 1989 as a way for Cooperative Members to give back to the community. One of the most rewarding aspects of Operation Round Up is that it is an extension of the concept of neighbor helping neighbor that built our Electric Cooperatives.

Funding for Operation Round Up is donated by Co-op Members like you who volunteer to round up their monthly electricity bill to the nearest dollar amount. For example, if your bill is \$85.75, it will be rounded up to \$86.00 and your contribution for the month would be 25 cents. This donation never goes above 99 cents per month; the average donation for the year is \$6 and the most it would be is only \$11.88! Collectively, these funds are then used to aid many worthy causes such as charitable organizations and community and school programs.

If MJM's Members vote to pass Operation Round Up, this does not mean all Members have to participate. Members will have ample opportunities to opt out of the program before implementation, if they wish. By opting out, your bill will remain unaffected and will *not* be rounded up.

One of MJM's seven principles is Concern for Community. While MJM strives to focus on Members' needs, Cooperatives work for the sustainable development of their communities. Just like Rosalyn Carter said, show you care and make this world a better place by starting in your own community.

Annual Meeting Minutes

March 23, 2019

The Annual Meeting of Members of M.J.M. Electric Cooperative, Inc. was held at the Carlinville High School, Carlinville, Illinois, on Saturday, March 23, 2019.

Registration began at 8:30 a.m. and the meeting was called to order at 10:00 a.m. by Chairman Robert Lehmann. The Boy Scout Troop 63 Color Guard presented the American Flag. Troop 63 then led the Members with the Pledge of Allegiance. The National Anthem was sung by Lauren Summers, Megan Dunn and Dustin White. The Members remained standing for the invocation by Phil Carson.

Brooke Gross came forward and presented the M.J.M. Scholarships to recipients-Damon Burdell of Litchfield son of Todd and Tami Burdell, and Alexis Egelhoff of Chesterfield, daughter of Ken and Lori Egelhoff.

Chairman Lehmann then welcomed M.J.M. Electric Cooperative Members, guests and friends to the 80th Annual Meeting of Members and introduced the M.J.M Board of Directors

Chairman Lehmann then announced that a quorum was present and called to order the business session of the 2019 Annual Meeting of Members of M.J.M. Electric Cooperative, Inc. pursuant to the Bylaws. A complete list of those registered in person and by proxy is attached to the official minutes of this meeting of the Cooperative.

Chairman Lehmann then turned the meeting over to Attorney Lee J. Plummer to address the proposed Order of the Day and Rules of the Day. Attorney Plummer referred the members to the proposed agenda as found on page three of the Annual Meeting Notice and pointed out that this agenda is in compliance and verbatim with M.J.M. Electric Cooperative's Bylaws. A motion was made and seconded to adopt the Order of the Day being the proposed agenda on page three of the 2019 Annual Meeting Notice. Upon voice vote, the motion carried.

Attorney Plummer then presented to the Members for their consideration the following recommendations for the Rules of the Day, which

were unanimously approved by the Cooperative's Board of Directors at their December 2018 meeting:

First, that not more than 25 minutes be allocated to discuss each motion that is addressed; second, that during the consideration of the motion, each speaker may speak for up to three minutes unless no one else wishes to speak and that the chair will attempt to recognize speakers with alternating viewpoints; third, that during the question and answer period, each person may speak up to two (2) minutes unless no one else wishes to speak; fourth, that Robert's Rules of Order will govern the conduct of the meeting; and fifth, that the Cooperative's Attorney, Lee J. Plummer, will serve as Parliamentarian for this meeting. A motion and second was made to adopt these recommendations as the Rules of the Day. Upon a voice vote, the motion carried. Attorney Lee J. Plummer then called upon Secretary William Heyen to present the notice of the meeting.

Secretary Heyen read the Official Notice of the 2019 Annual Meeting of Members of M.J.M. Electric Cooperative, Inc., as mailed to all Members of the Cooperative, together with his affidavit of mailing of such notice to each member as required by the Bylaws.

Chairman Lehmann then announced that the next order of business would be the consideration of the Minutes from the Annual Meeting of Members held on March 24, 2018. He stated that Minutes had been printed in the Official Notice of the meeting that was sent to all of the Members of the Cooperative. Chairman Lehmann asked if there were any corrections or additions. Hearing no corrections or additions, there was a motion and second to approve the Minutes as printed and mailed. Upon voice vote, the motion carried.

Chairman Lehmann then called upon W. Kay Schultz, Cooperative Treasurer, for his report. Treasurer Schultz presented his report including directing the Members' attention to the printed financial information that was presented at the

Annual Meeting. He reported that MJM's audit for 2018 had been completed by the Jackson Thornton & Co. P.C Certified public Accountants. He further reported that the Board has reviewed that audit. Then Treasurer Schultz discussed the results of that audit and ended by pointing out that a complete audit report as submitted by Jackson Thornton & Co. is available at the Cooperative office for any Member that wishes to review it.

CEO Laura Cutler then welcomed visitors including Gary and Karen Higgins from Wabash Power Cooperative; Duane Noland, Ashley Graham, Paul Dow, Nancy McDonald, Nick Reitz and Ambyr Crawford all of the Association of Illinois Electric Cooperatives; Phil and Joyce Carson, NRECA Director, State Representative C.D. Davidsmeyer and State Representative Avery Bourne.

Laura Cutler, President/CEO introduced Illinois State Representative Avery Bourne. State Representative Bourne addressed the membership about the revitalization plan for down State of Illinois.

Laura Cutler, CEO then introduced Illinois State Representative C.D. Davidsmeyer. State Representative Davidsmeyer addressed the Membership.

Laura Cutler, President/CEO of MJM, then presented her report to the Members.

Laura Cutler, CEO then introduced Phil Carson, NRECA Director. Director Carson then addressed the membership.

Brooke Gross explained that MJM had another \$1,000 scholarship to give out and it was announced that they would draw out names of students that attended the meeting to receive 1- Five Hundred Dollar Honorary Scholarship and 5- One Hundred Dollar Honorary Scholarship. The \$500.00 Honorary Scholarship went to Ryan Croxford. The \$100.00 each Honorary Scholarships went to Libby Roth, Lindsey Miller, Joseph Rosentreter, Bailey Lippold and Grace Berry.

Chairman Lehmann then turned the chair over to Attorney Plummer to conduct the business session of the meeting. Attorney Plummer stated that the next item of business was the consideration of the Election and Credentials Committee report. Registration was closed at this time. Thomas Connors, Chairman of the 2019 Election and Credentials Committee

At the close of Thomas Connors' Election and Credentials report, Attorney Plummer then asked if there was a motion and second to elect by acclamation the candidates for districts 1, 6, and 9 as certified by the Election and Credentials Committee. There was then such a motion and second, which upon a voice vote carried, electing Directors as follows: W. Kay Schultz, Godfrey, Illinois – District 1, William Heyen, Gillespie, Illinois – District 6, and Marcie Tonsor, Jerseyville, Illinois– District 9. A copy of the Election and Credentials Committee report is attached hereto and made a part of these minutes.

Attorney Plummer then asked if there was any unfinished business to be brought before this meeting. There being no unfinished business, Attorney Plummer then said that next item on the agenda was a 30 minute questions and answer period and called for questions. Rich Littlemeyer, addressed the membership about electric cars and the effect it would have on M.J.M. A response from CEO Laura Cutler followed. Next, Bob Johnson, a Member, addressed the membership regarding solar power. Dana Wagner discussed easements and how many were needed per site.

Attorney Plummer then asked if there was any new business to be brought before the assembly of members at that time. There being none, there was a motion and a second to adjourn. Upon a voice vote, the motion carried, and the business session of the meeting was adjourned.

Operations - Major Projects Completed in 2019

Electric Operations Projects

ROW (Right-of-way) maintenance:

500 miles of distribution lines were cleared in the areas of Womac north, south, east & west; Staunton north, south, east & west; Hornsby north, south & west; Bunker Hill north, south & east; and Honey Bend west = \$998,559. In addition, hazard trees and hot spots were addressed = \$108,648.

297 miles of distribution lines were sprayed in the areas of Brighton north & south and Newbern north & south = \$45,179.



Pole Inspection and Replacement:

The annual pole inspection conducted by Lee Inspection and Consulting consisted of testing 2,643 poles located on the north feeder out of the Brighton substation. Of these poles, 222 were marked as needing replaced. MJM line crews as well as J.F. Electric Crews worked on replacing 312 poles from prior inspections, and 177 poles for line upgrades and revamped services = \$599,528. Crews also worked to address maintenance issues found-like loose hardware or damaged cross arms. An additional 123 poles were installed by J.F. Electric which are included in the cost of the work they performed below.

Rebuild, Relocate and System Improvement Projects:

The Cooperative undertook a number of rebuild, relocation and system improvement projects throughout the service territory. These are among a few:

- (1.018 miles) Upgrade on a 3-phase line conversion to remove old copper line and replace with aluminum wire on Atwater road - *Contracted to J.F. Electric - \$108,514.*
- (2.02 miles) Line conversion upgrade from single phase to 3-phase. *Contracted to J.F. Electric - \$199,874.*
- Due to issues with voltage drop in back-feed scenarios, we rebuilt 1.38 miles of old cooper weld line out of the south feeder of the Butler substation and replaced with aluminum wire - \$141,426.
- (1.16 miles) Converted single-phase line to 3-phase line thru Lake Rinaker down to Eikens Sawmill due to load imbalances - \$105,317.
- (1.68 miles) Single-phase copper line was re-spanned, replaced with aluminum wire and moved out of the private - \$93,490.
- Ameren Midway Transmission Line project - changing poles to steel. MJM was required to change its under-build on Ameren's transmission poles as a system improvement. *Contracted to L.E. Myers - \$25,375.*
- Miscellaneous maintenance improvements - \$76,739.
- Retired vacant and/or inactive services - \$30,526.
- Member line extensions, service improvements and new services, etc. - \$632,773.

Facilities & Equipment

- Retired 2 bucket trucks, and 2 service trucks, and purchased a 55' crew bucket truck - \$219,419; a 40' bucket truck - \$154,361; and a 2020 International CV service utility truck - \$72,231
- Purchase 3 defibrillators - \$4,188
- Purchased software for NISC Call Capture (integrates with the Outage Management System) - \$4,900
- Purchased an electric pressure washer - \$3,758
- Purchased a John Deere Gator Utility Vehicle - \$14,422
- Bunker Hill Substation upgrade and transformer replacement - \$234,077
- Jerseyville Substation transformer replacement - \$253,266
- Replaced and/or added 416 meters - \$143,274
- Replaced and/or added 193 transformers - \$281,074
- 390 Outdoor light conversions to LED and/or new installs - \$177,165



Information Technology (IT)

- Replaced 2 office desktop computers and CEO laptop - \$4,000
- Moved Aclara TNS / TWACS server to new virtualized hardware (meter communication to office from substation)- \$7,700
- Relocated GIS Mapping server to new virtualized hardware - \$8,000
- Setup new Alcara ONE server (web interface) to eventually replace older AMI TWACS system - \$13,500
- Purchased IT wiring and security camera system for new HQ - \$18,000
- Acquired network equipment for new HQ - \$6,000
- Continued advanced IT training for employees and directors via phishing simulations.
- Sustained administration of vulnerability and security information / event management systems.
- Switched phone services from Vonage to Crexendo to enhance compatibility with NISC software.

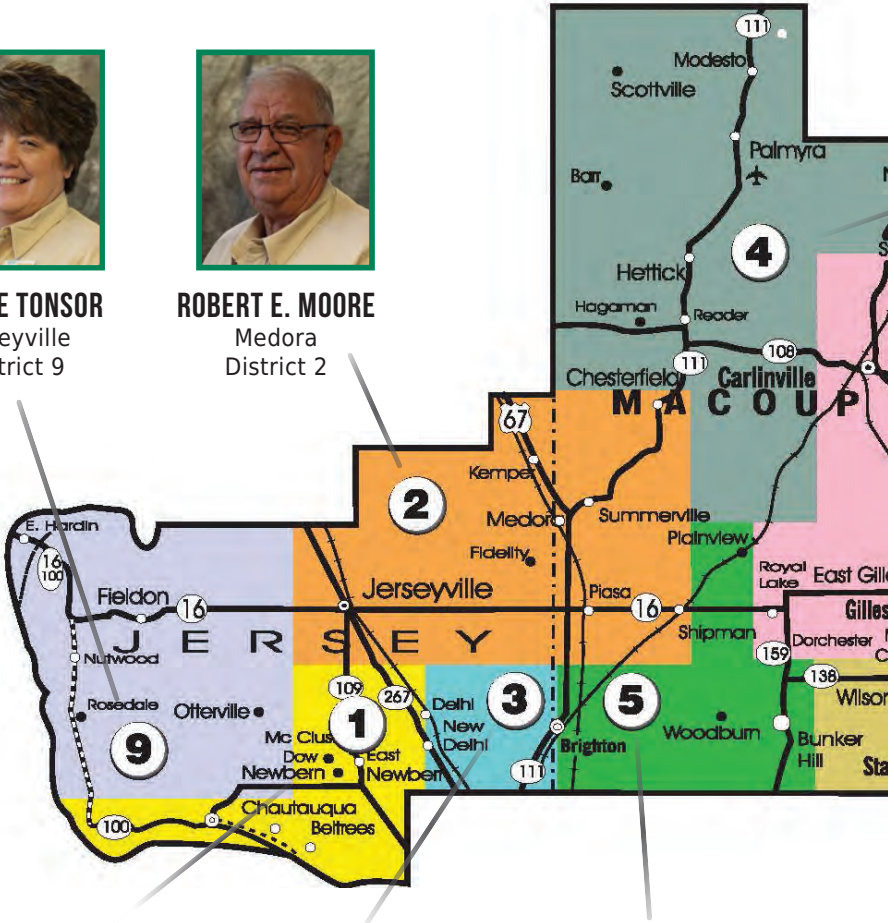

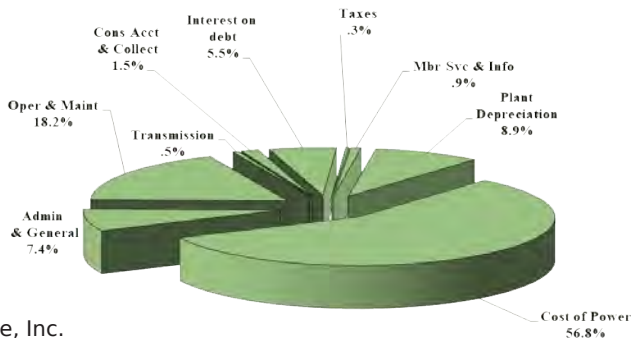
