Covid-19 has changed the way we all go about our day-to-day activities. It has also changed the way we will be having your MJM 2021 Annual Meeting on Friday, June 4, 2021. This year the board and staff have a new and exciting way for you to attend the meeting. We are taking precautions to make your Annual Meeting safe so you can attend the meeting. We are going to have our first ever drive-thru Annual Meeting. You will see the Board of Directors and familiar employees' faces directing you through the route at the new MJM headquarters at 18300 Shipman Road, Carlinville.

Through this pandemic our Cooperative employees have been making the needed changes to serve you and uphold the safe, reliable, and sustainable electric service you are accustomed to. We appreciate our Members' patience and understanding as COVID slowed the progress of meeting with our Members as we normally do throughout the year.


Things are always changing here at MJM. Paul Bartlett, who has been one of your board of directors from 1987 to 2021 retired on February 25, 2021. Paul has been representing MJM for 34 years! Paul's term expired this year, but he retired before his official term was up. Therefore, Charles Huebener was appointed to fill his seat. Charles has been an active member of the MAC (Member Advocate Committee) and we are pleased to see that he wants to continue to be an ambassador and advocate for MJM and continue on as a director.

The financial position of your Cooperative is solid and in 2020 we ended the year with \$2,592,103 in total margins. Our energy sales decreased mainly due to fewer KWH sales in the large commercial sector while residential helped offset some of that loss. Due to the way Members used their power during the Pandemic caused a historically low demand billing by our wholesale supplier (WVPA). This allowed

MJM to give a \$500,000 margin rebate back to Members on their January 1st, 2021 bills.

Because of COVID, your coop took steps to cease disconnections for non-payment and suspended the imposition of late payment fees for the months of March through July and have temporarily implemented more flexible credit and collections procedures to assist Members in remaining connected. MJM did experience a loss of Revenue from late penalty and disconnect fees of approximately \$55,000 during this period.

We continue to see a decrease in our line loss (KWH purchased less KWH sold) which was down 1% from 2019 to 5.41% (a savings of \$110,904). This

is below the IL Co-op average of 5.85% and directly related to the aggressive ROW maintenance program, removing inactive accounts, and performing line upgrades.

Expenses were down for the year because in-person meetings and training could not occur due to the pandemic. Many were held via Zoom, but several were also cancelled. ROW clearing and spraying costs were down almost \$400,000 compared to previous years because the territories in this cycle due for maintenance were not as extensive.

Interest expense was down as a result of being approved for funding of \$705,920 through the Small Business Administration from the Paycheck Protection Program (PPP). Monies were used to help fund payroll costs, including benefits, pay for mortgage interest, rent, utilities, and worker protection costs related to COVID-19. \$1Million was in the budget to be borrowed, but due to the PPP funding it did not become necessary. The PPP funds were forgiven thus the money was booked as income to MJM. This gain of income was offset by the loss on the disposal of the old MJM headquarters' buildings (\$288,000) that were auctioned off on October 24th, 2020.

The Board of Directors approved the retirement of deferred patronage capital credits again last year in the total amount of \$659,163. These credits were distributed on Members' October 1, 2020 bills if you were an active Member and by checks if you were an inactive Member. Your Cooperative has paid a grand total of \$4,367,846 back to the Members, one of the benefits of being a Member.

Our current debt balance includes rolling the bridge line-of-credit on the new head-quarters into long-term debt. Even though an additional \$1.5 Million was borrowed since 2019, \$1.3 Million has also been paid back. MJM was scheduled to move into the new headquarters and open its doors on April 23, 2020. Due to COVID, that was put off to July 22, 2020. A ribbon cutting ceremony was not able to take place, therefore, on July 22, 2021 exactly one year after the move in date, a ceremony will transpire.

The March 7, 2020 annual meeting was held the week before the country was shut down. Our vision for roaring into the 20's was to be innovative in addressing industry challenges, forward thinking in system maintenance and improvements, invest in our community and above-all, member-focused. To mention a few of our successes a new logo was created, a new headquarters completed, an Operation Round Up program was developed, a new Member Advocate Group was formed, 3 towers were installed on MJM properties for operational enhancements and future expansion of internet services, and pursuit of offering our Members other types of services continues to progress.

MJM remains committed to our mission and building for the future.

Annual Meeting Minutes - March 7, 2020

The Annual Meeting of Members of M.J.M. Electric Cooperative, Inc. was held at the Carlinville High School, Carlinville, Illinois, on Saturday, March 7, 2020.

Registration began at 8:30 a.m. and the meeting was called to order at 10:00 a.m. by Chairman Robert Lehmann. The Lucky Birds 4-H presented the American Flag. Lucky Birds 4-H then led the Members with the Pledge of Allegiance. The National Anthem was sung by Rockabilly Revival. The Members remained standing for the invocation by Cliff Woodman.

Chairman Lehmann then welcomed M.J.M. Electric Cooperative Members, guests and friends to the 81st Annual Meeting of Members and introduced the MJM Board of Directors.

Chairman Lehmann then announced that a quorum was present and called to order the business session of the 2020 Annual Meeting of Members of M.J.M. Electric Cooperative, Inc. pursuant to the Bylaws. A complete list of those registered in person and by proxy is attached to the official minutes of this meeting of the Cooperative.

Chairman Lehmann then turned the meeting over to Attorney Lee J. Plummer to address the proposed Order of the Day and Rules of the Day. Attorney Plummer referred the Members to the proposed agenda as found on page three of the Annual Meeting Notice and pointed out that this agenda is in compliance and verbatim with M.J.M. Electric Cooperative's Bylaws. A motion was made and seconded to adopt the Order of the Day being the proposed agenda on page three of the 2020 Annual Meeting Notice. Upon voice vote, the motion carried.

Attorney Plummer then presented to the Members for their consideration the following recommendations for the Rules of the Day, which were unanimously approved by the Cooperative's Board of Directors at their December 2019 meeting:

First, that not more than 25 minutes be allocated to discuss each motion that is addressed; second, that during the consideration of the motion, each speaker may speak for up to three minutes unless no one else wishes to speak and that the chair will attempt to recognize speakers with alternating viewpoints; third, that during the question and answer period, each person may speak up to two (2) minutes unless no one else wishes to speak; fourth, that Robert's Rules of Order will govern the conduct of the meeting; and fifth, that the Cooperative's Attorney, Lee J. Plummer, will serve as Parliamentarian for this meeting. A motion and second was made to adopt these recommendations as the Rules of the Day. Upon a voice vote, the motion carried. Attorney Lee J. Plummer then called upon pro-tempore Secretary Paul Bartlett to present the notice of the meeting.

Pro-tempore Secretary Bartlett read the Official Notice of the 2020 Annual Meeting of Members of M.J.M. Electric Cooperative, Inc., as mailed to all Members of the Cooperative, together with his affidavit of mailing of such notice to each Member as required by the Bylaws.

Chairman Lehmann then announced that the next order of business would be the consideration of the Minutes from the Annual Meeting of Members held on March 23, 2019. He stated that Minutes had been printed in the Official Notice of the meeting that was sent to all of the Members of the Cooperative. Chairman Lehmann asked if there were any corrections or additions. Hearing no corrections or additions, there was a motion and second to approve the Minutes as printed and mailed. Upon voice vote, the motion carried.

Chairman Lehmann then called upon W. Kay Schultz, Cooperative Treasurer, for his report. Treasurer Schultz presented his report including directing the Members'

attention to the printed financial information that was presented at the Annual Meeting. He reported that MJM's audit for 2019 had been completed by the Kevin S. Kelso, CPA, P.C., PA, Certified Public Accountants.

He further reported that the Board has reviewed that audit. Then Treasurer Schultz discussed the results of that audit and ended by pointing out that a complete audit report as submitted by Kevin S. Kelso, CPA. is available at the Cooperative office for any

member that wishes to review it.

CEO Laura Cutler then welcomed visitors including former employees Bob Heyen, Ron Dugan; Glen Holliday, George Holesko. Also, Duane Noland, Maurice Shallow, Chris Reynolds, Jim Pauley, and Connie Newenham all of the Association of Illinois Electric Cooperatives. Also visiting were State Senator Steve McClure and State

Representative Avery Bourne.

Laura Cutler, President/CEO introduced Illinois State Senator Steve McClure. State Senator McClure addressed the Membership about State of Illinois politics.

OPERATIONS - MAJOR PROJECTS COMPLETED IN 2020

Electric Operations Projects

ROW (Right-of-way) Maintenance

311 miles of distribution lines were cleared in the areas of Witt north, south, east & west; Taylor Springs north, south, east & west; and Butler north & south = \$555,140. In addition, hazard trees and hot spots were addressed = \$74,270.

500.6 miles of distribution lines were sprayed in the areas off of Bunker Hill, Honeybend, Hornsby, Staunton, and Womac substation feeds = \$75,155.



Pole Inspection and Replacement:

The annual pole inspection was conducted in-house this year which consisted of 1,308 poles located on all feeders out of the Hornsby substation and the north feeder out of the Witt substation. Of these poles, 76 were marked as needing replaced and 26 needing maintenance. MJM line crews replaced 216 poles from prior inspections, and 329 poles for line upgrades and revamped services = \$402,348. Crews also worked to address the maintenance issues found-like loose hardware or damaged cross arms = \$109,806.

Rebuild, Relocate, and System Improvement Projects:

Even though COVID prevented MJM from accomplishing some of the work plan projects, the Cooperative undertook a number of rebuild, relocation and system improvement projects throughout the service territory. These are among a few:

- (3 miles) Rebuild cooperweld to aluminum conductor on Route`6/ Prairietown Road- *Portion was contracted to J.F. Electric* – Total project \$210,647.
- (2.5 miles) Line rebuild on Kemper Road by replacing conductor \$157,859.
- (1.5 miles) Conversion of Single-phase overhead conductor to Threephase to East Alton Way Road; built down Arbor Lane; resagged existing conductor with new conductor; and relocated oil circuit reclosurers from Arbor Lane to Macoupin Station Road- \$113,312.
- Three-phase service for new Carlinville headquarters building \$69,397.
- (.25 miles) Replaced underground primary due to fault in section of the line at Lake Catatoga \$42,635.
- Retired vacant and/or inactive services \$42,638.
- Member line extensions, service improvements and new services, etc.






TREASURER'S REPORT

I, Robert E. Moore, am the duly elected, qualified, and acting Treasurer of M.J.M. Electric Cooperative, Inc. The financial statements in the annual report are based upon a complete and independent audit of the Cooperative's books and records for year ending December 31, 2020 and was performed by Kelso Lynch, P.C., P.A. and completed on March 18, 2021.

As part of obtaining reasonable assurance about whether the Cooperative's financial statements are free of material misstatement, the auditors examine records relating to the receipt of loan funds and the construction and acquisition of property, plant, and equipment. During the year, MJM received \$5M in long-term advances from the National Rural Utilities Cooperative Finance Corporation (CFC) on loans controlled by MJM's banker, the CFC Mortgage and Loan Agreement. Plant additions totaled \$6,908,621.

MJM had strong positive margins for the year ending 2020 and was able to meet the Debt Service Coverage ratio required by its lender, CFC. As a not-for-profit, any margins, or revenues remaining after all expenses have been paid, are returned to Members in proportion to their usage of the co-op's services through capital credit allocations and retirements.

2020 margins were allocated back to the Members in the form of capital credits on Members' May 1, 2021 bill and appear as equity on the Balance Sheet. Equity is used to help meet the expenses of the co-op, such as paying for new equipment to serve Members and repaying debt. Capital credits represent each Member's share of the cooperative's margins and ownership of the co-op. Capital credits help by reducing the amount of funds that must be borrowed.





Savin' the Butterflies and the Bees!



Due to the rapid disappearance of Monarch butterflies, in the spring of 2019, it was alerted to Coops nationwide that an order could happen that would prevent right of way clearings if the Monarchs were listed on the endangered species list. By ceasing all right of way clearing, it would allow vegetation to continue to grow and become a habitat to the Monarchs and other pollinators. Of course, without right of way clearing, vegetation growth would cause outages and that would cause MJM to go back on its promise to Members to deliver reliable and sustainable energy.

Thankfully, the Monarch butterfly never made the endangered species list at this time. If it had, MJM would fall under the Wabash Valley Power Association (WVPA) umbrella for this ruling. In the meantime, WVPA was considering voluntarily creating monarch butterfly habitats on a case-by-case basis for locations that would be suitable. This planted a seed in MJM to see what part it could have in saving the butterflies as MJM had an unused ¾ acre plot just south of the headquarters.

CEO/President Laura Cutler and Communication and Member Services Coordinator Brooke Gross were familiar with Master Gardener Mary Tinder and Carlinville's Beautification Project which consists of creating pollinator plots. After much planning and preparation with Tinder's and Dear Schramm's (WVPA) guidance, MJM was ready to place its pollinator garden that would benefit both the butterflies and the bees! Master Gardener Layne Knoche drew up a tentative long-term plan for the garden which includes a couple of walking paths and benches.

MJM has seven cooperative principles. One of which, is the concern for community! MJM has decided that this will take a few phases to complete the native plant filled Community Pollinator Garden. This is due to time and dedication that will be given to each phase to ensure that MJM provides a beautiful garden.

On Saturday, April 17th, the Carlinville Beautification Project kicked off their Earth Week celebration by attending MJM's ribbon cutting ceremony to honor MJM's Community Pollinator Garden. A handful of MJM employees, volunteers, and master gardeners worked alongside each other in the rain planting shrubs and beginning to mulch the garden. Charlie and Jeannette Baker donated a tree in memory of long-time employee Robert Heyen who recently passed away. MJM donated a tree in memory of Mayor Demuzio and Steve Parr who were instrumental in assisting with the site of the new MJM headquarters but did not live to see the completed project due to COVID and the CDC guidelines.

Because this is a community garden, if an individual feels so inclined to provide native plants to the plot, please do so. You may contact Brooke Gross, 217-707-6028, or if you come to the annual meeting, feel free to drop one off. Donations are accepted! Gross has high hopes of taking her son's senior pictures at this site one day. It is called long-term planning as he is only 7 months old! But we do hope the garden will be a site that many will come to visit and enjoy in the future.
