

Board Chairman and
President/CEO's Report

Welcome to the 83rd MJM Electric Cooperative Annual Meeting. This is my first annual meeting as your CEO, and I look forward to meeting and speaking with as many Members as possible. MJM has experienced many challenges this past year. We went from a Global Pandemic to seeing unprecedented increases in costs and extra-long lead times on practically everything we use. This is not just the utility industry; it is affecting our households, farms, and small businesses as well. Inflation and interest rates are on the rise and global unrest continues to be a concern for all of us. These market pressures are expected to affect the wholesale price of the energy that we purchase at minimum through 2022.

At MJM we are taking steps to mitigate these issues so that we can continue to provide safe, affordable electricity for our Member Owners. Our operations department has done an excellent job working with our vendors to reduce material and equipment costs wherever possible. Our linemen are doing their part as well, by re-using hardware and routing their trips and jobs more efficiently. Our IT department is working to protect our electronic files and communications from possible cyber-attacks.

Beginning January 1, MJM added three new employees to form a forestry crew. This is the first time since the "70's" that we have had an in-house crew. The forestry crew will be responsible for line clearance trimming, hazard tree removals, and right of way spraying. This move is projected to save MJM Members thousands of dollars each year in vegetation management costs.

Within the next two years, we will have three of our senior linemen retiring. In preparation for this we currently have three apprentice linemen in training. The lineman training program is a four-year apprenticeship which consists of an extensive educational platform as well as on the job training.



The financial position of your Cooperative remains strong. We ended the year in 2021 with \$1,496,960 in margins and we retired a total of \$626,570 in capital credits. The investment in the forestry equipment amounted to \$500,000 and we were also able to replace two bucket trucks and a digger derrick for another \$594,000.

Line construction and system maintenance continued despite some delays with material deliveries. For 2022, we have expanded our pole replacement program and we expect to replace upwards of 400 poles. We have also begun the process of adding a distribution substation in the Nutwood area to alleviate loading issues that we experience during frequent river flooding.

Kay and I would like to recognize Bill Heyen. This will be Bill's last Annual Meeting as he will be retiring from the Board after 37 years of dedicated service to MJM. Bill has provided many years of insightful guidance to the Board, and we thank him for his service to MJM.

The Operation Round Up Committee has been very active this past year. The committee has donated \$21,500 to a variety of organizations throughout the entire MJM service territory. The committee continues to meet regularly to review applications and dispense funds for worthy projects. We are very proud of the work this committee does and the time they are willing to donate for this cause.

MJM remains committed to our mission and building for the future.

CEO Laura Cutler announced that a quorum was present and called to order the business session of the 2021 Annual Meeting of Members of M.J.M. Electric Cooperative, Inc. pursuant to the Bylaws. A complete list of those registered in person and by proxy is attached to the official minutes of this meeting of the Cooperative.

Electric Operations Projects 2021

ROW (Right-of-way) Maintenance:

171 miles of ROW were cleared in the areas of Newbern and Nutwood. These are MJM's most rugged areas to maintain. The contracted cost for this work was \$997,830. In addition to that, we cut hazard trees throughout the territory in the amount of \$61,775.

311 miles of distribution lines were sprayed in the areas of Butler, Taylor Springs, and Witt. The cost for this service was \$41,858.

Pole Inspection and Replacement:

Lee Inspection Service completed inspections on 2087 poles for a cost of \$17,485. They identified 98 rejects and 197 poles that required maintenance. This service includes visual/sound testing with random boring to determine pole conditions. They also provide MJM with photos and GPS locations, as well as repairing broken pole ground wires and installing missing guy markers. In total we replaced 157 poles due to accidents and maintenance issues.

Rebuild, Relocate, and System Improvement Projects:

- Butler substation, upgrading structure, transformer, and fencing
- Fieldon substation, new sub for flood area and load improvements
- Rinaker substation, tower base repair and switch upgrades
- Libery Ridge, line conversion and extension for new loads
- Bunker Hill, line rebuild and conversion to three phase, system improvement
- Numerous line extension and upgrades including several three phase conversions
- Palmyra area, 5-mile single phase line rebuild.







TREASURER'S REPORT


I, Robert E. Moore, am the duly elected, qualified, and acting Treasurer of M.J.M. Electric Cooperative, Inc. The financial statements in the annual report are based upon a complete and independent audit of the Cooperative's books and records for year ending December 31, 2021 and was performed by Kelso Lynch, P.C., P.A. and completed in April of 2022.

As part of obtaining reasonable assurance about whether the Cooperative's financial statements are free of material misstatement, the auditors examine records relating to the receipt of loan funds and the construction and acquisition of property, plant, and equipment. During the year, MJM received \$533,000 in long-term advances from the National Rural Utilities Cooperative Finance Corporation (CFC) on loans controlled by MJM's banker, the CFC Mortgage and Loan Agreement. Plant additions totaled \$3,019,820.

MJM had strong positive margins for the year ending 2021 and was able to meet the Debt Service Coverage ratio required by its lender, CFC. As a not-for-profit, any margins, or revenues remaining after all expenses have been paid, are returned to Members in proportion to their usage of the co-op's services through capital credit allocations and retirements.

2021 margins will be allocated back to the Members in the form of capital credits on Members' July 1, 2022 bill and appear as equity on the Balance Sheet. Equity is used to help meet the expenses of the co-op, such as paying for new equipment to serve Members and repaying debt. Capital credits represent each Member's share of the cooperative's margins and ownership of the co-op. Capital credits help by reducing the amount of funds that must be borrowed.

A summary of the financials is found on page 15 - 17 of this annual meeting booklet. Further explanation of the financials is discussed in the Board Chairman and President/CEO's report found on pages 4 & 5. A copy of the audit report is available for your inspection at the MJM office.




